

MPHA EXECUTIVE MEETING MINUTES – February 26, 2024 Meeting called at 6:38pm

Topics covered

1. Approval of minutes from last meeting – Krista motioned to approved Ashley seconded all in favour

2. U18 assistant coach suspension – During the U18 game on February 24th the assistant coach received a bench minor and indefinite suspension under OWHA Rule 11.

Tamey will have a discussion with the bench staff on appropriate behaviour while on the bench. The coaches need to know the severity of their actions as well as the negative impact it has had on the team.

3. U22 Elite Team update -Sudbury's executive had approved the application for the team and forwarded it to OWHA. Sudbury will be appealing the decision. Tamey will keep us updated on any decisions.
